Steve G0KYA agreed that the alternate was a compromise that he thought we had all agreed to previously and was probably the way to go for the near future.

Roger thought the same as Steve.

Sonny thought the forum gave us a mandate to go forward with the Hybrid, in person and online. He was worried that the pressure on producing the Online could become a pain for David/Tammy. The constitution shouldn't be considered an issue due to un precedented times. We can address this in the future through EGM etc if a change is considered necessary in the future.

Jim G3YLA supported Steve's comments to try for a period the in person/ Online format. The club has supported and spoken through the forum and online form so we should take that route. The constitution shouldn't be considered an issue due to un precedented times.

David suggested that he &Tammy are happy to continue going forward with online presentations, but holidays should be catered for.

We should think about structure and schedule, i.e in-person 1st 3rd weeks, online- 2nd 4th, a 5th Wednesday in the month becomes an in person at a different venue maybe.
